

**PUBLIC UTILITY AND SURFACE STORM
DRAINAGE EASEMENT**

Reserved for Deed Records Use

By this instrument _____,
(Grantor) in consideration of the sum of \$ -0-
received from the City of Beaverton, Oregon, a
municipal corporation (Grantee) does hereby grant,
bargain, sell, and convey to Grantee, its successors
and assigns a perpetual easement and right-of-way
for the purpose of construction, grading,
maintenance, repair, and reconstruction of surface
or subsurface storm drainage, sanitary sewer,
electrical and communication lines, and supporting
or ancillary structures, and planting or removing
vegetation, over, across, in and through the real
property owned by Grantor located in the County
of Washington and the State of Oregon and more
particularly described as follows:

Grantor understands and agrees for itself, its successors and assigns not to cause or allow the construction or maintenance of any building or other structure in or upon the area conveyed without the prior written consent of Grantee, which may be granted or allowed in Grantee's sole discretion. Grantor understands and agrees that Grantee may cause the summary removal of any such building or structure so placed without Grantor's consent and that Grantor shall make no claim for and shall hold Grantee harmless from any claim by a third person for damage to or destruction of the property so removed.

Grantor further agrees for itself, its heirs, successors and assigns that it shall not cause or allow any act or occurrence or condition of land that disturbs the subjacent or lateral support of the area conveyed and that Grantee shall have the right of reasonable access over any property adjacent to the area conveyed, for the purpose of construction, grading, maintenance, repair, and reconstruction of surface or subsurface storm drainage, sanitary sewer, electrical and communication lines, and supporting or ancillary structures, and planting or removing vegetation, in or on the area conveyed and the right to remove any structure necessary or convenient to accomplish same.

Grantee agrees to stabilize any disturbed soil surface resulting from Grantee's activities. Stabilization to be accomplished by vegetation planting, application of erosion control fabric, or other means considered practical.
