Fire report (presented by TVFR):

There were 144 calls in our NAC consisting of, 11 for fire and 130 for EMS.

Captain Annen asked, "Can you turn off your water, gas and electricity?" He wanted to point out how important this is in case of an emergency and provided handouts on how to do this.

He also encouraged to get heaters, furnaces and chimneys check as colder weather approaches.

Police report (presented by Officer Christian Corning):

Car set clinic on Sept. 22nd.

There is a violent offender at large – Maticio-Beltran-Trejo.

There was a lot of discussion and confusion about the new light at the fire station on Farmington. Officer Corning will bring information to next month's meeting.

Traffic enforcement is doing more pedestrian stings. There have been a lot of notice going out.

Trudy – Thanks police for catching carjackers of co-workers car on Milliken.

There was some concern that it takes too long for children to exit school buses. Officer Corning explained that there has to be eye contact between driver and parent at some stops. He also

explained that you must stop for all flashing lights unless there is a physical barrier in the middle of the road.

Bill Wood – Thanked police for catching a habitual stop sign runner in the Four Seasons neighborhood.

Guest Presentation:

Chris Mcquire – His house, located on 158th, backs up to the power line trail.

August 22nd received a letter to remove encroachments from the park for new construction. He (and others whose homes back up to the power line trail) do not feel it was appropriate the way the park district handled it. They would like the WB NAC to act as a 3rd party for the homeowners. BPA has never has a problem with the plants as long as the homeowners maintained them. In 2010, TVPRD said the plants were OK and now they have changed their mind wanting plants to be removed. Removing the plants can caused erosion and other problems. Also, other houses along the existing trail have extended their lawns and nothing is being said about that.

Comment – Some are concerned where the property lines are located and whose responsibility it is to locate them.

Bruce – We need to get involved. Need to contact Dick Schouten. Contact representatives.

Debbie Nicoli – Principal at Chehalem Elementary School.

The school needed a reading program and Bill Wood and the WB NAC started the Pages for Pillars program.

Bill Wood – Home libraries are important. Helps maintain reading level over the summer.

Debbie – Sixty percent of kids that attend Chehalem are living below the poverty level. We need to work with students to help with listening and speaking skills. We need to try to get books to kids that need them the most.

Debbie talked about the tremendous value Bill brings to the school.

Sue talked about Bill winning the NAC member of the year award.

Bill – We were able to raise over \$2100 from the garage sale last July.

Debbie thanked Hilde for running the Chess Club and to the NAC for the support.

Bill submitted matching funds request to the city and will be getting \$1000 from them.

Hilde – Why don't we have SMART?

Debbie – The program cut its funding.

Beaverton has deposits of \$10,000,000 in several local banks at \$250,000 in each bank. Banks must be Oregon based.

The city has hired a one year Cultural Diversity Position.

TVPRD will put a light at Fanno Creek crossing on Hall Blvd.
